In light of recent improvements to governance of sport internationally we wish to recognize and mirror the best practice objectives of the IOC Athletes' Commission. The role of the IOC Athletes Commission is to: "represent athletes within the Olympic Movement and support them to succeed in their careers".

MOTION :

A motion to amend the Constitution of the QWA that:

One (1) of the four (4) Ordinary Member positions on the QWA Management Committee be set aside for an athlete commission representative.

The Qld Weightlifting Association is to set-up an Athletes Commission of three (3) men and three (3) women from current QWA athlete members, that have lifted in an official AWF endorsed competition in the past 2 years and are 18 or over.

The method of selection of the six (6) members of the commission shall be as a result of an online vote by QWA athlete members who are 18 or over from EOI received in the month prior to the annual AGM.

The athlete commission will internally vote a chair that is notified to the QWA Management Committee in writing. This representative will then fill the eighth position on the QWA Management Committee at the time of the AGM.

Athlete Commission need to progress to an exhaustive ballot if there is a tie for the position of Chair.
